**Notes:**

1. From Section 15.3 of the constitution of the Singapore Malayalee Association, the Interpretation of the term Malayalee is:

'Malayalee' for the purposes of the Association shall be :

- One whose mother tongue is Malayalam; or
- One whose ancestors were of Kerala origin; or
- One who has a parent who belongs to (1) or (2) above; or
- One who is married to a person belonging to (1) or (2) or (3) above.

2. Types of Membership, gist of qualification criteria

Ordinary Membership is extended to Malayalees, aged 18 and above, who is a Singapore Citizen or Permanent Resident (PR) are eligible for life / Ordinary (yearly) Membership.

Associate Membership is extended to Singapore Citizens or PRs, not eligible to be an Ordinary/Junior member

Junior Memberships are available for Malayalees, less than 18 years as on date of application who is Spore Citizen or PR.

Corporate Membership are granted by the Management Committee(MC) to Businesses / Corporations / Organizations

Term Memberships are available for Malayalee, any age, who is NOT a Spore Citizen / PRs, residing in Singapore

3. Membership Fees

Corporate Membership: \$1000

Life Membership: \$200

Ordinary Membership / Term Membership / Associate Membership: \$30 per annum

Junior Membership: \$15 per annum

Requirements/conditions:

1. The subscription fees above are correct at the time of printing. The amounts can be varied from time to time by the decision by the Management Committee. Please check with the General Secretary for the prevailing rates.

2. The application duly signed by the applicant shall be forwarded to the Honorary General Secretary together with subscription fees in advance. Acceptance of the application shall be at the sole discretion of the Management Committee, who has the right to accept/reject any application without assigning any reason for its decision. In the event the application is rejected, the applicant will be informed and the fee paid refunded. Successful applicants will be issued with a receipt for membership fee paid/copy of Constitution/Membership Card.

3. Membership card need to be presented when demanded while at Association premises, attending meetings, voting etc.

4. In the event of Lost or Damaged Membership cards the member shall inform the Hon. General Secretary immediately and apply for a fresh card paying the necessary cost for replacement.

5. Any changes to the information given in this application, including change of address/contact information such as telephone/mobile/e-mail etc shall be informed to the Hon. General Secretary immediately in writing. Communications send by ordinary mail /e-mail to the last given address shall be considered as having been duly served on the day following the date of posting or the day of e-mailing.

6. Members are requested to pay the subscription fee and renew the Annual Memberships before its expiry. If the subscription is in arrears for more than 3 months from the date of expiry, the membership gets cancelled automatically. In the event of the member receiving a notice in this regard, please ensure that your response reach back the Association within 14 days. If the membership ceases, the same shall be notified in the Association's Notice board for a reasonable period and the person will no longer enjoy accrued benefits (if any). However the person can apply for fresh membership.

7. Members taken up membership one month prior to the date of Association's closing of financial year (31st December) only shall be entitled to vote or stand for elections at General Meetings.
